## Description & Accommodation

The property comprises the upper floors of a traditional end terrace unit.

The property is self-contained with a separate entrance door with external shutter which leads in to a hall (NOTE the adjacent shop has an emergency exit over this area.)

The property has a mezzanine extension to the rear which contains two toilets each with lobby and a single office of 46m<sup>2</sup> (492ft<sup>2</sup>)

Stairs lead to the first floor which comprises a single office over the whole front of the building and a rear office.

The second floor has a landing with under stairs storage cupboard, two front offices and a rear office.

To the third floor are two attic store rooms, the rooms are in the eaves so parts have limited head room.

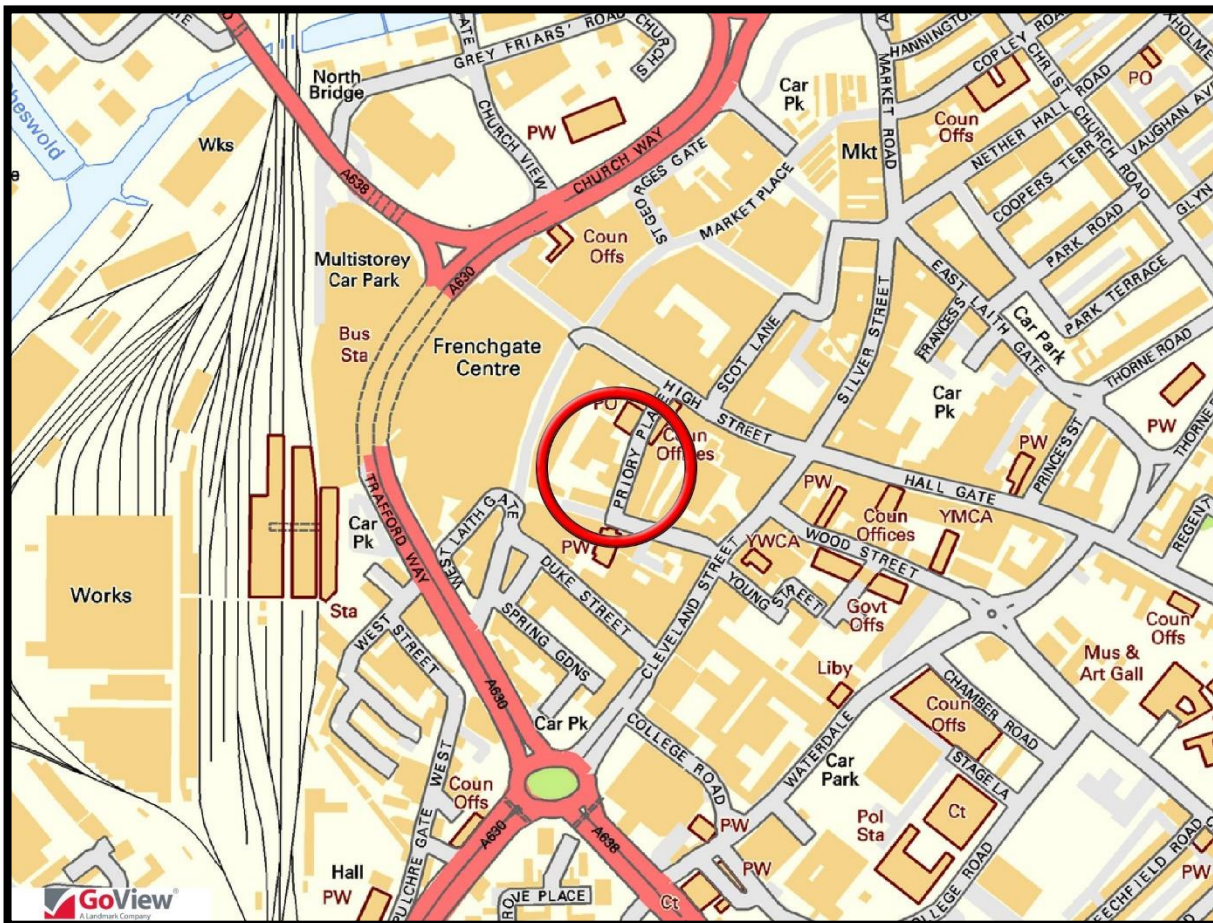

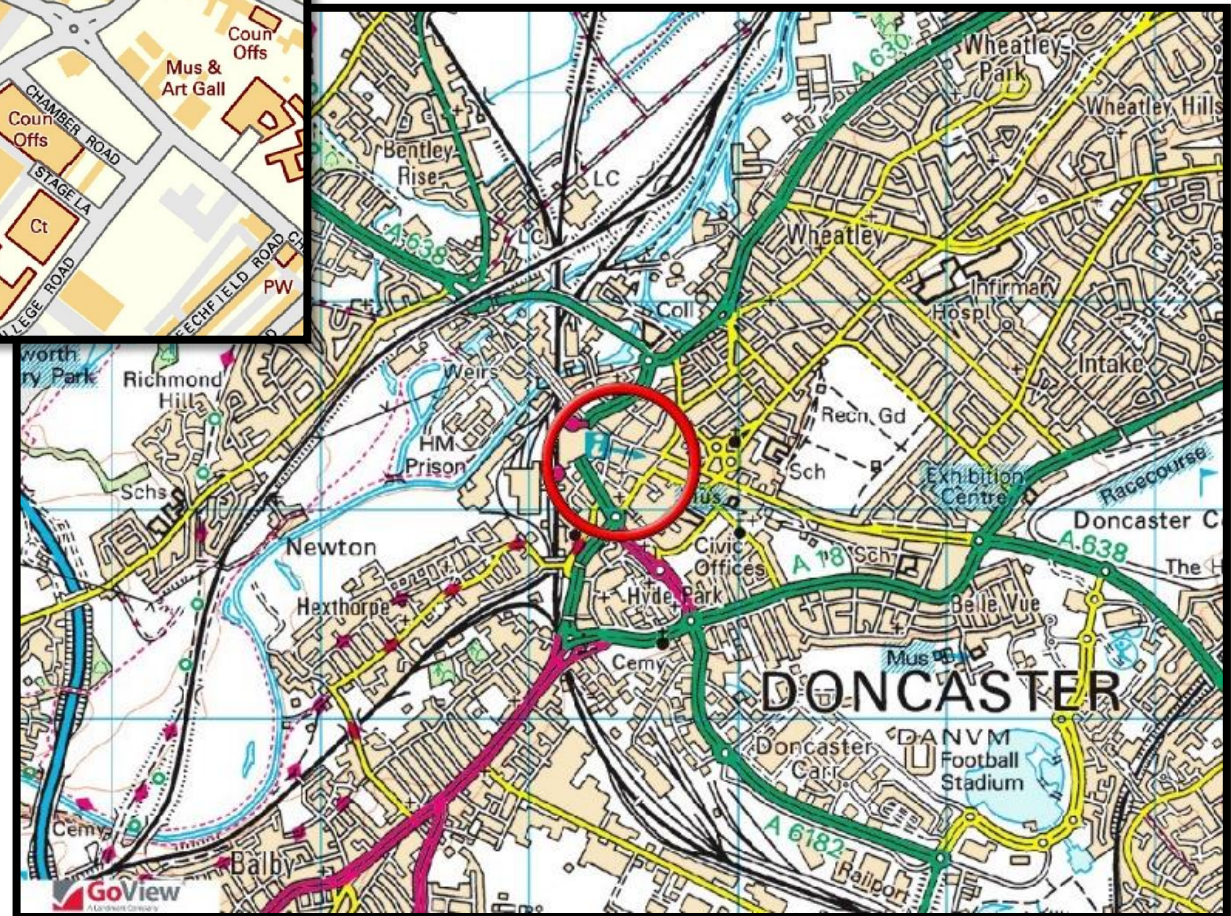

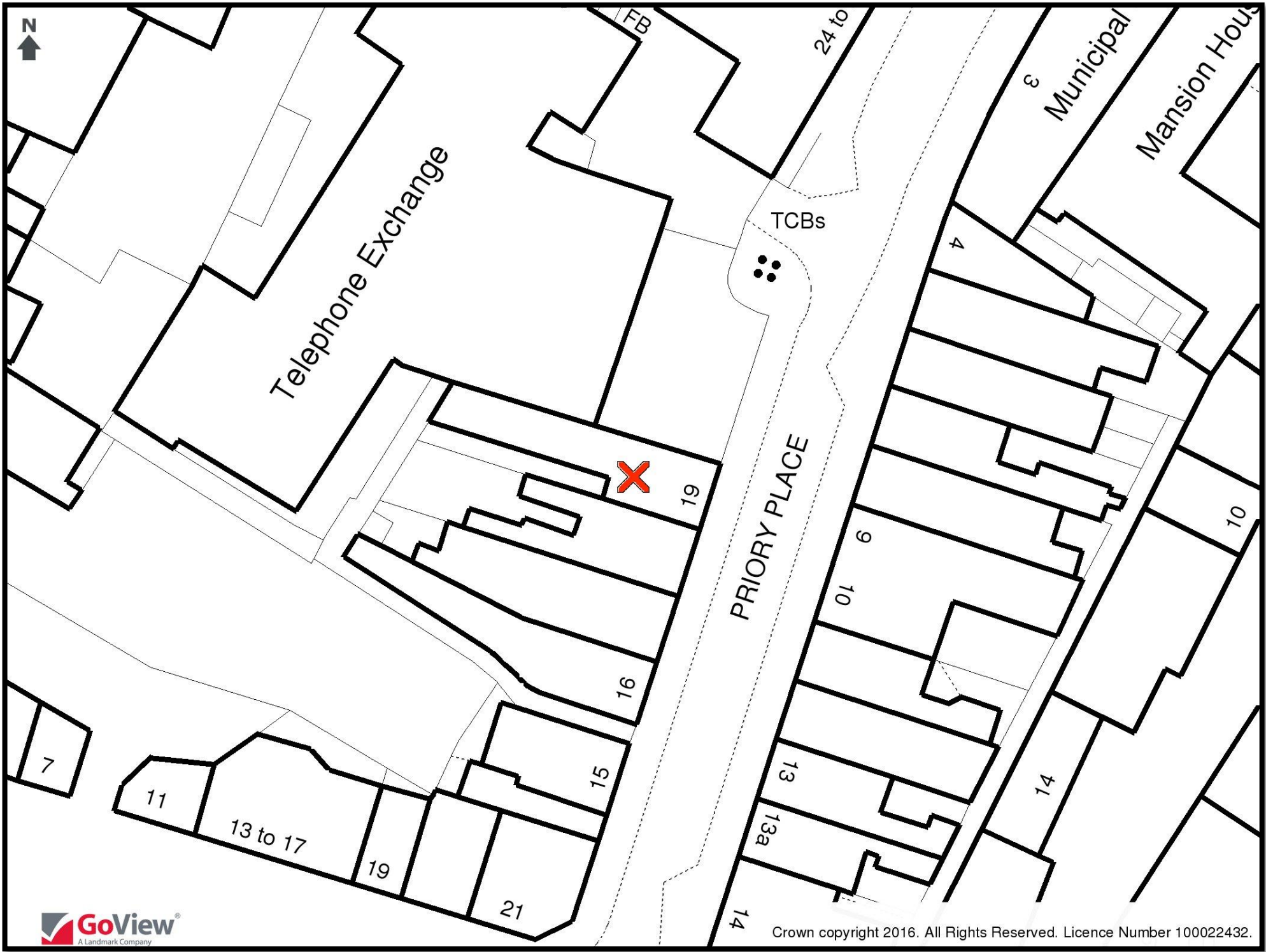


## Location
